In accordance with Chapter 113-27D of the Public Laws of St. Mary's County, Maryland, being part of Article 19 of the Code of Public Local Laws of the State of Maryland, notice is hereby given that a Public Hearing will be held on Monday, April 8, 2019 at 6:00 p.m. at the MetCom Administration Building, 23121 Camden Way, California, Maryland. The Hearing will be held to discuss the proposed Fiscal Year 2020 Capital Improvement Budget, the proposed Fiscal Years 2021-2025 Capital Improvement Plan and the proposed Fiscal Year 2020 Operating Budget and proposed rate changes relating to each budget, to become effective July 1, 2019.
