

PUBLIC HEARING NOTICE
ST. MARY'S COUNTY METROPOLITAN COMMISSION (MetCom)

In accordance with Chapter 113-27(D) of the Public Laws of St. Mary's County, Maryland, being part of Article 19 of the Code of Public Local Laws of the State of Maryland, notice is hereby given that a Public Hearing will be held on April 15, 2025 at 6:00 p.m. at the MetCom Administration Building, 23121 Camden Way, California, Maryland. The Hearing will be held to discuss the proposed Fiscal Year 2026 Capital Improvement Budget, the proposed Fiscal Years 2027-2031 Capital Improvement Plan and the proposed Fiscal Year 2026 Operating Budget and proposed rate changes relating to each budget, to become effective July 1, 2025.
